3. Pledge of Allegiance

Councilor Briese led the Pledge of Allegiance.

4. <u>Discussion on Access Management Strategy for US 97, 1st - 6th Streetscape Project Gary Farnsworth from ODOT</u>

Gary Farnsworth was via the telephone. He said the Streetscape Project Report will be presented at the next Council Meeting. Construction will begin in the spring of 2018. Mr. Farnsworth said they want to be very transparent with the project. He said they will recommend all the access ways for the project. Mr. Farnsworth said they will work with each property owner on the recommendations. He said letters have been sent out to the effected property owners on the west side. Mr. Farnsworth said they are only making a couple of changes on the eastside. He said they will also cover pedestrian crossings. Councilor Greiner expressed concern about the property lines and if they may need to be corrected. Mr. Farnsworth said, in regard to this project, that changes will not be done at that time. He said they will not prohibit a property owner from adjusting their property lines. Councilor Martinez discussed the re-alignment of 6th Street and Finley Butte Road. Mr. Farnsworth said they will be disclosing to Deschutes County that they are making some changes on the west side of Hwy 97. He said they did emphasis safety in the design for pedestrians. Mr. Misley said the property owners have been included in the discussion on frontage and access that has been used for several years. He also discussed all the work that ODOT had done for the project. Mr. Farnsworth said they have put in the project several pedestrian crossings. There was a discussion as to why the crossings were located at where they were planned to be. The new speed limit will be moving down from 35 mph to 30 mph. Also, the warning light for crossing will be taken down.

5. <u>Discussion on Zoning Ordinance Amendment to Allow Recreational Marijuana Retailers and follow-up on Time, Place, Manner for Medical Marijuana and Recreational Marijuana Proximity</u>

Tammy Wisco, City Planner, was present via the telephone. She said this ordinance would allow marijuana retail (either medical or recreational) in particular zones, only. Ms. Wisco said they wanted to know if the Council would like the marijuana retail allowed only in traditional commercial zones or additional zones. Ms. Wisco discussed some of the transition areas in the City. The Council had consensus to allow only the traditional commercial zone for marijuana retail. They also had consensus not to allow the marijuana retail in transitional areas. Ms. Wisco said the ordinance will probably come back to the Council sometime in March. Most of the Councilors thought that mixed use commercial should be an allowable zone for marijuana sales. The time, place and manner would be referenced in the conditional use application for marijuana sales.

6. Introduction with Steve Parnell, Economic Development Sunriver/La pine Area Director

Mr. Parnell discussed the advisory group SLED (Sunriver La Pine Economic Development) that he will be working with and receiving direction from. He said he is also working on marketing La Pine, especially for encouraging new businesses to come to La Pine. His former employment was as a teacher for La Pine High School. There was a discussion on available housing for employees of new businesses coming into La Pine. Also discussed was the need for upkeep in some of the established neighborhoods.

Cory Misley said Housing Works had received monies from the State to build low-income housing in La Pine.

7. Public Comments

Brian Earls, business owner, asked about the cinder in the swales. Mr. Misley said that Public Works Manager, Jake Obrist, is discussing the problem with ODOT.

11. Public Comments

Melissa Marcotte, area resident, said she was called by the police and asked to be the point of contact for South Deschutes County. She said there are many serious issues for seniors and others, due to the heavy snow conditions. Ashley Williams said that a lot of the costs to FCS were due to the rate study for water and sewer, only a small portion was for the SDC study.
