Chair Myers covered the previous proceedings of the public hearing for file 01TA-24 and opened deliberations. Commissioner Meyers covered the written comments that were submitted during the open record period. Commissioner Accinelli spoke about the size of 20-foot flag lots and the need to see bigger, however 50 feet seems too large. Commissioner Accinelli thought 30 feet seemed appropriate. Staff’s recommendation and contract City engineer also recommended a 30-foot requirement. The commissioners talked about how 20 feet was very narrow for two cars or fire trucks.

Chair Meyers re-read Mr. Huffmann’s comments that were added into the record. Commissioner Baumann reiterated how 20 feet was too narrow, and commissioner Hatfield agreed. Principal Planner Bybee mentioned that Commissioner Baumann should not vote since she was absent during the last hearing.

Commissioner Accinelli moved to approve, Commissioner Hatfield seconded. No discussion. Roll call vote, 3 in favor, one abstained (Commissioner Baumann).

1. Long Range Planning Update (Discussion only)

Principal Planner Bybee talked about the recent summit at the beginning of the month, and how there was a good turnout of 50 people. Moving forward we are issuing an online survey so people can address goals or policies. Mr. Bybee urged the commission to send out the survey to other people which closes on Monday 10/21. We are putting together the scope of work for TGM grant that was awarded to the City. Mr. Bybee is working with an ODOT rep on some materials that are due mid-November. Will need to send out RFP through the states website for a consultant to help with the TGM grant.

Friday we will be presenting at the Chamber of Commerce breakfast. Mr. Bybee will be at the State Planning Conference at the end of the week. An email was sent out regarding training for the Planning Commission and City Council. There will be some form of public engagement event this winter, we are working with the consulting firm on what that will look like.

Associate planner Vickers mentioned there was no update or new files since the last time the Planning Commission met and current files have slowed down a bit since summer but based on pre application meetings and talks with our SLED director, the is expected to change shortly.
